#### REPORT OF SCRUTINIZER (Consolidated report on e-voting and poll)

The Chairman 32<sup>nd</sup> Annual General Meeting of Equity Shareholders of Jay Bharat Maruti Limited (L29130DL1987PLC027342) held on Saturday, 14th September, 2019 at 10.30 A.M at Air Force Auditorium, Subroto Park, New Delhi-110010.

I, Sunita Mathur, Practicing Company Secretary (Membership No. FCS 1743, CP No.741) was appointed as Scrutinizer for the purpose of scrutinizing the voting process through remote e-voting which commenced from Wednesday, 11th September, 2019 (10:00 a.m.) and ends on Friday, 13th September, 2019 (5:00 p.m.) and poll taken in respect of resolutions as set out in the Notice of the 32<sup>nd</sup> Annual General Meeting of the Equity Shareholders of the Company, held on Saturday, 14th September, 2019 at 10.30 A.M.

The management of the Company is responsible for ensuring the compliance with the requirements of the Companies Act, 2013 and Rules relating to remote e-voting and voting by Ballot Paper on the resolutions contained in the Notice of the 32nd AGM of the members of the Company. My responsibility as a scrutinizer for the remote e-voting process and for Ballot Paper at the AGM is restricted to make a Scrutinizer's report of the votes cast "in favor" or "against" the resolutions stated in notice of the AGM, based on the reports generated from the remote e-voting system provided by National Securities Depository Limited (NSDL) and physical ballot conducted at the AGM.

I submit my report as under:-

- 1. As per Notice dated 16<sup>th</sup> July 2019 for convening 32nd Annual General Meeting, the evoting period remained open from Wednesday, 11th September, 2019 (from 10:00 a.m.) and ends on Friday, 13th September, 2019 ( upto 5:00 p.m.)
- 2. The advertisement as stipulated under Section 108 read with Rule 20 of Companies (Management and administration) Rules, 2014 as amended on 19th March 2015, were published in Business standard (Hindi) on 23rd August, 2019 and Business standard (English) on 23rd August, 2019 in New Delhi edition
- 3. The shareholders of the Company holding shares as on the "cut off" date of Friday, 6th September, 2019, were entitled to vote on the resolutions as contained in the notice of the 32nd Annual General Meeting.
- 4. The total paid up Equity share capital of the company as on "cut off" date i.e. as on Friday, 6th September, 2019 was Rs. 10,82,50,000 {Rupees Ten crore Eighty Two Lakhs Fifty Thousand only) divided into 2,16,50,000 equity shares of Rs. 5/- (Five) each.
- 5. The Chairman of the 32<sup>nd</sup> Annual General Meeting (AGM/ "Suo Moto" ordered for poll as per Rule 21 of the companies (Management and Administration) Rule 2014.
- 6. Two empty ballot boxes were duly locked and sealed in my presence. They were put for collecting ballot papers and polling was declared closed by the Chairman of the meeting at 11.40 A.M.
- The locked ballot boxes were subsequently opened by me, and poll papers were diligently scrutinized. The poll papers were reconciled with the records maintained by the Registrar and Transfer Agents of the Company and the authorizations/proxies lodged with the Company
- 8. The poll papers, which were incomplete and/or which were otherwise found defective have been treated as invalid and kept separately
- 9. The Company accordingly has made arrangements with the System Provider NSDL for providing a system of recording votes of the shareholders electronically through remote e-voting.



- 10. The Company has also provided voting facility to the shareholders present at the 32nd Annual General Meeting and who had not already cast their vote through remote e-voting facility to vote through Ballot Paper.
- 11. After conclusion of voting by Ballot paper at the Annual General Meeting, The votes cast thereat were recounted, whereas the votes cast under remote e-voting facility were thereafter unblocked in the presence of two witnesses (i) Mr. S.S.Mathur and (ii) Mr. Rhishabh Swami who were not in the employment of the Company.. They have signed in confirmation of the votes being unblocked in their presence.
